






① Prof. Manita Rao - Dean/H.O.D.



① Pre Ph.D examination (DET) paper will be based on Objective type questions comprising of 100 marks. Each question will carry 01 mark. Question paper will be divided in two parts each having 50 objective type questions.

One part will be based on Research Methodology and other part will be based on Constitution, I.P.C., Cr.P.C. evidence act, Civil Procedure Code, Election Law, Family Law, Human Rights etc.

(Sc/St/OBC) Candidates with 50% marks will be eligible for interview whereas PH candidate with 45% will be eligible

② Interview will be of 100 marks.

- Research Potential
- Communication Skill
- Subject knowledge in the respective area of research.

Merit list will be prepared on the basis of marks obtained in interview.

③ With due permission of Chairman the credits for B.A.LL.B(Hons); LL.M CBCS course; B.A.LL.B five year course; LL.M Two year course were calculated and analysed which were unanimously accepted and enclosed.
