- (iv) Prof. R.C. Maurya, Subject Expert, Retired Professor, Department of Chemistry and Pharmacy, R.D. University, Jabalpur.

The following decisions were taken unanimously.

For CBCS-Course:

- (i) The course code CHC205: Computer for chemist of the second semester should be shifted to first semester with the course code CHE101A: Mathematics for chemist and CHE101B: Biology for chemist as second section.
- (ii) The course code CHE402C: Environmental chemistry of the fourth semester is shifted to second semester as course code CHC205: Environmental chemistry with the addition of biodiversity and green chemistry in Vth unit of the course.
- (iii) The two new courses: certificate course in analytical spectroscopy/chromatography are proposed with their respective syllabi.
- (iv) Project work/Dissertations of M.Sc. Chemistry is shifted from III semester to IV semester. The marks increased of project work/dissertation work will be 200.
- (v) Credits of all theory courses are being increased from three credits to four credits. The credits of practical course are being reduced from 3 credits to 2 credits.

The project work as an internal assessment is effective from summer or winter.

For non-CBCS Courses

- (vi) The course computer for chemist of the second semester of M.Sc. Chemistry will be conducted and evaluated internally by the concerned college. The marks will be uploaded by online to the university.
