
This has reference to your proposal submitted online for award of BSR Faculty Fellowship, I am pleased to inform you that on the recommendations of the BSR-Empowered Committee in its 98th Meeting dated 26.06.2020; the University Grants Commission has agreed to offer you BSR Faculty Fellowship. The Fellowship would be available from the actual date of joining up to the age of 68 years or up to three years (non-extendable) of the award whichever is earlier. The latest date for joining the award is the date of superannuation from your current position. The guidelines of the scheme are available on the UGC website: http://www.ugc.ac.in/pdfnews/4188867_BSR-Faculty-Fellowship-revised-guidelines.pdf.

You should join the fellowship immediately after the date of superannuation. The Fellowship amount shall be disbursed through Canara Bank to the bank account of the awardee (any bank) directly. The Universities/Colleges/Institutions will submit your update master data on the dedicated web-portal (<https://scholarship.canarabank.in>). The amount of fellowship and Contingency is as under:-

First, Second and Third Year : ₹50,000/- p.m.
Contingency : ₹5,00,000/- p.a.

It is informed that Aadhaar may be used as an identifier for disbursement of all Government subsidies / Scholarships / Fellowships, which are to be disbursed directly into the beneficiary's account in accordance with the instructions issued by the Government of India. The Universities / Institutions may terminate fellowship of any awardee in any of the following cases, under intimation to UGC:

- i) If the awardee is found to be ineligible to receive the award, at any point of time during the entire duration of the fellowship.
- ii) Misconduct of awardee.
- iii) Unsatisfactory progress of research work of the awardee.
- iv) If, any other fellowship drawn from other source(s).
- v) Concealment of facts and on any other ground of misconduct.
